Hope Alliance adjusted to the pandemic very well. Even prior to the availability of vaccines, we saw patients and with creativity and tenaciousness expanded the number of Utahns that we served! We increased the number of patients receiving and eye exams and prescription glasses by 48% from 2020 to 2021. Overall, we have increased the number of local patients served 4,000% from 2017 to 2021. We expanded our vision screening outreach program to students and their families to 5 counties in Utah: Emery, Grand, San Juan, Summit, and Wasatch county by 71%. In 2021, we also added an educational outreach component to our services through which we partnered with local elementary school teaching students about their eyes and how to care for them.
